## Who Are We:

The Scottish Women's Convention (SWC) is funded by the Scottish Government to engage with women throughout Scotland in order that their views might influence public policy. This is undertaken in a variety of ways including Roadshow events, Thematic Conferences and regional contact groups.

After consulting with women across the country, the SWC uses their views to respond to a variety of Parliamentary, Governmental and organisational consultation papers at both a Scottish and UK level. This allows for the real lived experiences of women to have a positive impact on the policy making agenda in Scotland and beyond.

#### Our main objectives are to:

- Consult with women and use their voices as part of the engagement process.
- Ensure all policy and decision making authorities take account of women's equality.
- Recognise and highlight the potential impacts which policies have on women.
- Promote the needs of different groups of women.
- Actively pursue solutions which look to achieve equality for women.

The current circumstances during the Covid-19 pandemic have turned our lives upside down. We recognise that each woman will have a unique experience of this time. It has remained the SWC's top priority to engage with women across the country, listening to issues and concerns and bringing women together to empower them.


Do Women In
Scotland want
another
Independence
Referendum?

The SWC held our last in-person Conference in February, bringing women together for discussions as to whether or not another Scottish Independence Vote should happen. All sides of the debate gathered to ensure a uniquely women-centred perspective and to voice their own opinions and experiences. This allowed women to come to a fully informed decision regarding the topic. The SWC also collated responses from an online survey around this to ensure women who could not attend still had their voices heard.

<u>Women &</u> Social Care Across Summer 2020, the SWC undertook work regarding women's experiences of social care in Scotland. This included digital roundtables, online surveys, submissions and phone interviews. We held our first online conferences on this area with two events, starting in September. We wanted to cover social care before and during the pandemic and what needs to change to make social care work for everyone. We supported our full Conference Report with various other documents to cover the wealth of information gained, including lived experiences and further information for women.

**Women & Mental Health** 

In late October, the SWC brought women together for an event covering mental health. We wanted to cover the many different and complex aspects of this topic and the ways it impacts women across Scotland. This year has been incredibly challenging, and the SWC aims to gather voices of women to shape the way responses to mental health are designed as we move forward. Due to overwhelming demand, we held a further conference, continuing to gather information from women and explore further opportunities.



The high level of engagement from women up and down Scotland has been incredible this year and inspired the SWC to create a host of new ways to keep this going, including an online Coronavirus Resources Page and various briefing papers of women's experiences and needs.

"Experiences of 2020" Blogs As the country moved to online forms of communication in 2020, the SWC launched a series of blogs. This showcased the differing realities of what 2020 meant for women from lockdown to easing of restrictions.

Women wanted to be involved, with blogs being launched weekly. This led to a virtual blog takeover by female members of the Scottish Youth Parliament throughout the month of November.

<u>Virtual</u> Roadshows Our Spring Calendar of Digital Roadshows took the SWC to locations across Scotland via video conference calls. Women discussed what was happening in their local communities in response to the pandemic, highlighting strong areas of support, causes for concern and what is needed going forward. The SWC have strived to ensure women who could not attend these digital events were included by using other forms of communication including phone interviews and online one to ones. These views were incorporated into reports based on local areas and fed back to policy makers.

<u>Universal</u> Basic Income Throughout the year, the SWC continued to hear from women about the prospect of Scotland introducing a Universal Basic Income payment to all as a way to combat poverty and inequality. Following this, an evidence gathering exercise was undertaken to capture women's views.

There was an overwhelming level of engagement and a report covering how UBI could benefit women's equality going forward was produced. We continue to consult with policymakers around this.



The SWC has also been working with decision makers and politicians to make a difference to women and their families. This has seen huge positive changes in policy and legislation which will impact not only in the present, but for many years to come.

<u>Period Products</u> (<u>Free Provision</u>) (Scotland) Bill This ground breaking piece of legislation was unanimously passed in the Scottish Parliament on 24 November 2020.

The SWC worked with Monica Lennon MSP and other women's organisations to ensure that no woman suffers from a lack of education or employment opportunities because she cannot pay for sanitary products.

Free School Meals during School Holidays Women constantly talk to the SWC about the hardship of providing meals during the days when children are at home. This is particularly acute during school holidays. We reported this to government officials through our roadshow reports and consultation responses.

The SWC were delighted to report back to those women that the Scottish Government have put in place a new initiative. Those who receive free school meals during term time will also receive them during holiday periods up until the end of March. This will go a long way in easing the financial burden on many women.

Scottish Child Payment The SWC has been working with the new Scottish Social Security Agency in several areas of the benefits being devolved to Scotland. We are active members of many of the Advisory Groups.

The new Scottish Child Payment has recently been announced. This weekly payment of £10 for every child under 6 years of age will go a long way in helping ease financial hardship for many women.
